# "Better to be a Criminal in China than a Pregnant Mother" Those who violate the one-child policy are more harshly punished than those who violate other laws

HE CHINESE MINISTRY of State Security must have been asleep on the job. The email that appeared in my inbox read: "It is better to be a criminal in China than a pregnant mother."

Now, I knew that women who get pregnant outside the state plan are often browbeaten or bullied into abortions and sterilizations. But as my mysterious correspondent noted, there are a whole range of other punishments for violators of the family planning policies of the PRC, who are treated worse than criminals.

First, she said, if you've had a child outside the plan, very few people will hire you. Most "work units" (i.e., businesses) require ap-

plicants to submit their "Family Planning Certificates" to prove that they have not had an "illegal" child.

Even criminals—burglars, rapists, and the like—are allowed to apply for jobs after they have been released from prison. But the parent of an "illegal" child without a "Family Planning Certificate" is not even allowed to apply!

Second, even criminals enjoy certain basic human rights, as laid out by Article 37 of the PRC Constitution. They cannot be detained without probable cause, they cannot be tortured or subjected to corporal punishment, and they have the legal right to file suit if their rights have been violated.

Those who violate the one-child policy are stripped of their dignity as human beings and enjoy no rights. They can be illegally detained for an indefinite period of time by the Family Planning Bureau. They can be forcibly aborted or forcibly sterilized. And, if they try to take legal action, they will find out that

# The One-Child Policy has Destroyed the Chinese Family

# More and more Chinese, denied children, are rejecting family life altogether

It wasn't so long ago that the ideal Chinese family was large, consisting of multiple generations, and sometimes multiple families, living together. In fact, author Lao She entitled his bestselling novel about life in Beijing under Japanese rule, Four Generations Under One Roof.

But that was before the one-child policy decimated Chinese families, discouraging the young from marrying and having children, aborting and sterilizing hundreds of millions of expectant mothers, and leaving the elderly bereft of the children and grandchildren who would have loved and supported them in old

The upheaval caused by the Party-State's intervention into the private lives of its citizens is reflected in a new report from China's National Health and Family Planning Commission (NHFPC), the bureau charged with enforcing the one-child policy. Not surprisingly, the report shows that family size is shrinking rapidly, from 5.3 people at the time of the Communist Revolution to only around three today.

The primary driver of this decline is, of course, the one-child policy, which allows urban couples only one child and rural couples two. This trend has been accelerated as the young flee to the cities in search of economic opportunity, leaving villages peopled by the very old and the very young.

There are now tens of millions of unmarried young workers living in and around the cities, along with large numbers of couples who have delayed having children or decided to remain childless. Then there is China's huge and growing population of elderly, living alone or as


Although the report, written by the population control enforcers themselves, doesn't blame these trends on the Party-State's policies, they are clearly to blame in every case. Take the tens of millions of unmarried young workers, for instance, who range in age from their mid-teens to their late twenties.


The report blames the young for delaying marriage to pursue career goals, save up for down payments on cars or houses, fulfill lifestyle choices, or wait to find the right mate. It ignores the primary reason why young people are waiting to marry: early marriage is against the law. The rules state that men can't marry until they are in their mid-to-late twenties, while women can't marry until they reach the age of 23 to 25.

And don't forget that, because of the selective abortion and infanticide of tens of millions of girls, there are an equal number of young men who will never marry, since the girls they would have married have been killed.

The constant barrage of anti-people propaganda has also had an anti-natal effect. When they are finally allowed to marry, many young couples choose to delay having their only child, or decide to opt out of the child-raising altogether. The number of married couples with children has, according to the report, declined "significantly", while the number of dingke families, (a Chinese transliteration of DINK, or which stands for families with "dual income, no kids"), has been

Finally, there is the rapid and ongoing aging of the Chinese population, which





no people's court at any level will touch cases involving family planning issues.

Third, according to Article 37 of the PRC Constitution, a person suspected

of a crime can only be arrested after an arrest warrant is issued by the People's Procuratorate or the People's Court, and the arrest can only be carried out by members of the public security bureau. A person suspected of a crime also has the right to hire an attorney to defend her from the charges during the trial. And she will not

be charged "room and board" for the time she spends in prison awaiting trial.

But here Zhejiang province, the Family Planning Bureau operates outside the law. It violates civil liberties by arresting and detaining whomever it wants, whenever it wants. Husbands and other family members are locked up on its own authority. Its victims are not allowed to

seek legal counsel. They are even forced to pay 20 or 30 Yuan a night for the "privilege" of being incarcerated.

Fourth, the law protects the unborn

child of a criminal, even if that criminal has been sentence to death. The authorities wait until the child has been born before carrying out the sentence.

The unborn child of a woman who becomes pregnant outside the one-child policy has no legal protection. Instead, the baby is sentenced to death. No matter what the reason, those who get pregnant without permission must terminate the pregnancy.

Finally, no matter where a criminal is detained, in a local jail or a state prison,

they are permitted to communicate with their family. On the other hand, a pregnant woman and her family members can be held incommunicado for however long the Family Planning Bureau wishes to hold them. And if they are unable to pay the fine for conceiving an illegal child, the child will be aborted or, if born, it will be sold. She will never see her child again in this life.

So you see, it is better to be a criminal in China than a mother pregnant without government permission.

# Why We Need to Teach *Humanae Vitae*Pope Paul VI's Encyclical on Life and the Family

In coming months, the Church will focus on the Magisterium's timeless teaching on human life, marriage, and the family.

This coming July 25th *Humanae Vitae*, the beautiful encyclical written by Pope Paul VI in 1968, will celebrate the 46th anniversary of its promulgation.

The world should join in: *Humanae Vitae* is a great gift to all humanity that explains what it means fully to be a member of the human family.

In 1968, Pope Paul VI knew that the world was in thrall to the "sexual revolution," propelled by the contraceptive mentality that slammed the door on life and turned to the Pill for an easy exit from responsibility and maturity.

Rampant abortion, divorce, disease, and cultural decline followed – as Pope Paul VI predicted.


In reaffirming the long-standing moral teaching of the Church and the Natural Law, Pope Paul VI knew that he was challenging the leaders of the Dictatorship of Relativism worldwide.

and parents to join in his valiant defense of life, the family, and yes, even civilization itself. But his pleas were ignored not only by the secular elite and the general public, but by many of his own bishops as well.

Two years ago, Timothy Cardinal Dolan, Archbishop of New York and President of the U.S. Conference of Catholic Bishops, made a remarkable confession to the *Wall Street Journal*.


When confronting the Obama administration's contraception mandate,

the Cardinal explained, "We've grown hoarse saying this is not about contraception, this is about religious freedom."

But why would the Church abandon the moral teaching and appeal to a legal principle, when the courts have been increasingly hostile to religious freedom?

The Cardinal's response is blunt: leaders of the Church have not been teaching moral doctrine "since the mid and late 60s," he said. "We have gotten

T IS HARD for persons in democratic societies to grasp how China's party-state can control the fertility of China's millions. The effort starts with a barrage of anti-child propaganda in the schools and workplaces, and then moves to open intimidation in banners and slogans posted in public places. Here are some pictures of the kind of public threats the authorities make against those women who may be pregnant with "illegal" children.



Above- Translation: "Call back those who are located far away, dig out those who are hidden, Those who are pregnant outside the policy absolutely must have labor induced. Those who should be sterilized absolutely must be dragged down."



Above- Translation: "If you are supposed to wear an IUD but don't, or are supposed to have your tubes tied but don't, you will be arrested on sight!"



Above- Translation: "Even if you bleed enough to make a river, you must not give birth to an extra child!" (Hunan Province)

"Those of you who
don't abort or get
sterilized, and are
happy to have
excess births and
pay fines. . . [image

Left- Translation:
"If it should be aborted and is not aborted, your house will be destroyed and your cow will be taken."

"If you should get sterilized and you don't, you will be detained and prosecuted. If you should abort and do not abort, your house will be torn down and your cattle will be led away."




This kind of in-your-face propaganda, combined with strong-arm tactics on those who hold-out, brings most women to heel. Then there are group pressure tactics, used in Liaoning province in northeastern China and elsewhere. In these provinces, second births are allowed only if there no illegal births. If even one illegal child is born, no second births are allowed, and women carrying second children are aborted.

Steven Mosher, who lived in China for several years and witnessed forced abortions commented, "It is hard to imagine the intense hostility, even hysteria, that these group pressure tactics would generate in a small, tightly knit rural community towards anyone who threatened to break the rules."

On the streets or in the workplace, on the television and in the newspapers, the Chinese people are bombarded with anti-people propaganda. Day after day this softening up process continues, so that when the midnight knock on the door comes, many pregnant mothers and their husbands do not even try to fight back.

### Armenia

Tert.am – Armenia's Ministry of Healthcare is considering introducing a measure to ban fetal gender determination until the 30th week of pregnancy. The measure is designed to halt the practice of sex-selective abortion, since Armenians have a cultural preference for boys over girls.

The director of the UNFPA in Armenia, Gavik Hayrapetyan, said that the sex ratio between male and female infants at birth was 114:100 in 2012. The normal ratio of males to females at birth is 105:100; rates much higher or lower than this are not found naturally and are usually the result of targeted abortions.

# **UK Doctors "Presigning" Abortion Consent Forms**

In February 2012, a government commission in the United Kingdom discovered 67 English doctors in 14 hospitals pre-signing the official forms required for women in Great Britain to undergo an abortion. The British House of Lords recently took note of this flagrant violation of the law. On April 3, Baroness Knight of Collingtree and several other peers asked the British Government, which has left corrective action in the hands of a medical professionals association, to prosecute this violation.

The debate included peers from all three major political parties with widely differing opinions on abortion. The discussion covered several other topics, including sex-selective abortion. While there was evident disagreement as to whether or not British abortion law bans sex-selective abortions, all peers who spoke on the topic condemned gendercide strongly. The debate concluded with a response from Earl Howe of the Department of Health.

The 50-minute debate raised questions about the status of the unborn in Parliament, where such discussions are few and far between. Britain has had virtual abortion-on-demand since the passage of the Abortion Act in 1967. The four grounds on which abortion is allowed are always loosely interpreted and sometimes—as the investigation showed—totally ignored.

Abortion activists make much of the relationship between a patient and her doctor. In the UK abortion business, however, as the presigned consent forms show, there is no relationship.

### **Spain**

(Mercator.net) A report from the profamily Institute of Family Policies (IPFE) asserts that Spanish family life is in crisis, and blames a collapse in the number of marriages, economic crisis, and an epidemic of broken marriages as reasons for the collapse of the Spanish family.

There are 51,997 fewer marriages in Spain today than there were in 1990, despite the fact that Spain has a higher population now. The total fertility rate in Spain is shockingly low; the total fertility of 1.32 children per woman is among the worst in Europe. Spanish economic decline has only exacerbated this trend, and

families with 3 or more children have faced a 19% drop in income since 2007.

(Lifesitenews.com) "At the first annual Rome Life Forum in Vatican City today, fifty-two pro-life leaders from sixteen nations called on the bishops of the Catholic Church to deny Holy Communion to proabortion politicians in a spirit of love and mercy.

The leaders signed a declaration noting that it is out of concern, and indeed love for those same politicians that the pro-life leaders ask for this wake-up call to invite pro-abortion politicians back to authentic faith."

The Rome Life Forum called upon Catholic bishops to uphold Canon 915 of the Catholic Church's Code of Canon Law which states that men and women "obstinately persevering in manifest grave sin are not to be admitted to Holy Communion."

Carlos Polo, Director of PRI's Latin American Office, was among the signers of the declaration. Polo declared, "This is an act of real Christian charity for some people who have misunderstood Catholic teaching. If you eliminate the consciousness of sin, including very grave sins, you are eliminating the consciousness of the presence of God. Both God and sin illuminate each other. To those who fight for Life and witnesses the tragedy of each and every abortion, the loss of the sense of sin- the eclipse of the pres-

gun-shy . . . in speaking with any amount of cogency on chastity and sexual morality."

"The flashpoint was *Humanae Vitae*," Cardinal Dolan continued. "It brought such a tsunami of dissent, departure, disapproval of the church, that I think most of us—and I'm using the first-person plural intentionally, including myself—kind of subconsciously said, 'Whoa. We'd better never talk about that, because it's just too hot to handle." Our bishops had "laryngitis," he said.

Nonetheless, Cardinal Dolan admitted that "he sees a hunger, especially among young adults," for *Humanae Vitae*. Furthermore, he said that the youth are now demanding that the Church speak authoritatively on issues of sexuality. "They will be quick to say, 'By the way, we want you to know that we might not be able to obey it... But we want to hear it. And in justice, you as our pastors need to tell us, and you need to challenge us!"

How curious. Our young people want to hear it the truths of *Humanae Vitae*, but many of our bishops desperately avoid addressing the morality of contraception – even when opposing the "Contraceptive Mandate"!

The same "laryngitis" afflicts their opposition to homosexual "marriage." Instead of taking the opportunity to highlight the Church's moral teachings on the immorality of homosexual acts, they avoid it like the plague – as Cardinal Dolan candidly admits, albeit with a sigh.

As a result, in confronting both of these moral challenges, the bishops have thrown themselves on the mercy of Caesar's secular courts.

Even there, they do not demand that the courts acknowledge the Declaration's "Laws of Nature and of Nature's God," the foundation of all of our freedoms. Such an argument would be clear, forceful, and final, regardless of what the Supreme Court' political majority might decide. After all, Holy Mother Church can never abdicate to any secular court the authority to define morality. More importantly, Cardinal Dolan is right. The world hungers for the truths of *Humanae Vitae*.

Let us pray that, in this historic year, our bishops will hearken to the call of Our Lord: "Feed my sheep!"

children, you are going to have a problem with elder neglect. A certain amount is simply baked into the policy.

For thousands of years, elderly Chinese had lived with their children and grandchildren, but that is rapidly changing too, as young people leave their hometowns for education and employment opportunities. According to the report, 90 percent of China's elderly live at home instead of assisted living facilities. But their children and grandchildren often choose not to live with them, or cannot live with them. The problem is particularly acute in rural areas: Millions of young farmhands have left for factories and construction sites, while rural social security and healthcare resources are comparatively sparse, leaving many elderly to fend for themselves in squalid conditions.

A nascent social security safety net is being built in rural areas, but is not yet particularly sturdy. According to the report, over 40 percent of senior citizens above the age of 80 live alone. The report cites another study that shows 37.5 million elderly Chinese citizens lacked the ability to care for themselves in 2013.

A quarter of all elderly lived below the poverty line. In a survey released by the NHFPC, 80 percent of Chinese households say they are worried about supporting their elderly relatives.

Responding to the report on social media, Chinese web users expressed concerns about the future of Chinese families and what it means for the country's economic and social development. Zhi Xiefei, a professor at Nanjing Information Technology University in wealthy Jiangsu province, wrote that China "would not be able to achieve sustainable growth" based on these demographic trends. Many blamed China's longstanding family planning policy, which restricts millions of urban families to only one child per couple. Despite a major reform to the policy in December 2013 that allowed certain urban couples to have two children, bureaucratic red tape remains thick, and the cost of raising children may prove prohibitive to some couples.

To be sure, there is one bright spot in the report, at least for enterprising real estate developers with an eye on the long term. The report projects that China will have 500 million households in 2040, compared to 430 million today, because of the trends toward smaller families. That could mean more demand for urban housing units in the decades to come.

For everyone else, the report is likely to stoke concern. It shows anxieties about the expense of caring for children and parents weighing on Chinese families; that, in turn, is likely to reduce their propensity to spend, just as the Chinese economy becomes increasingly reliant on a burgeoning consumer culture to bolster its growth. For Chinese policymakers, this may be the wake-up call they need to continue to reform the country's much-maligned family planning policy. It may get increasingly rare for four Chinese generations to live in one home. But neither need there be so many families of one.

Aborto Cero ("Abortion Zero") is the title of the most important pro-life book ever published in the Spanish-speaking world. The controversy has led the publisher, Stella Maris, to place thousands of billboards and posters on city streets in Spain. The billboards show the cover of the book with a banner across it saying, "The book that many do not want you to read."

(The Telegraph) Oxford economist Ian Goldin warns that 70 percent of the world's population, specifically in Western and emerging countries, is living in areas facing looming population declines. Professor Goldin cites growing urbanization and levels of women's education as a factor, noting that as the costs of having children increase in urbanized societies, children are viewed by couples as a burden rather than an asset.

Goldin warns that this birth dearth potentially has massive negative repercussions for the world economy. "More people means more creativity, more geniuses. More and more people means more and more extraordinary things for the planet. When we ask if the planet is too full we are questioning whether people in the future have a right to exist. And I am not sure anyone would say that about their own grandchildren."

### **Africa**

(Allafrica.com) – The British medical journal The Lancet has published a series of papers demanding unified international action to reduce the high infant mortality rate in Africa.

9 of the 10 highest infant mortality rates in the world are found in Africa. The country with the highest rate is Sierra Leone, which has 49.5 deaths for every 1000 live births. Many of

these deaths are preventable. Lead author Joy Lawn argued that "over 70 percent of newborn deaths are preventable with currently available techniques." The studies claim that many steps to reduce infant mortality, such as "kangaroo care" [skin-to-skin contact between a newborn and a caregiver], neonatal resuscitation, and breastfeeding, can be implemented at the rate of \$1.15 per person per year.

A number of groups – the World Health Organization (WHO), the UN Children's Fund, the Bill and Melinda Gates Foundation, and Save the Children – have endorsed these initiatives as "the clearest picture to date of a newborn's chance of survival and the steps that must be taken to end preventable human deaths." One hopes that these groups will prove as active in preventing the deaths of newborns as they have been in forcing contraceptive pills and injections on their mothers.

#### Italy

(*The Local*) According to The National Institute for Statistics (Istat), Italy's main supplier of official statistical information, the number of Italian births has dropped dramatically in recent years. 515,000 children were born in 2013 – 64,000 fewer births than in 2008. Italy also has the second-oldest population in Europe – there are 151.4 people over the age of 65 for every 100 people under 15 years of age.

The Italian economy contracted in the first quarter and Italian GDP (gross domestic product) is projected to grow by less than 1% in 2014. Istat is planning to include estimated sex trade and drug trafficking revenues in future calculations for the year 2015, according to *The Local*, "in a move expected to boost its economic results."

### **Ukraine**

(FiveThirtyEight.com) - Like many of its European counterparts, Ukraine is shedding population at a frightening rate. Since the collapse of the Soviet Union in 1990, the population has declined by 6.3 million people to 45.6 million in 2012, this according to Ukrainian government figures. This downward trend shows no signs of slowing: the United Nations predicts that, according to its most likely projection, Ukraine's population will fall to only 34 million by 2050.

Several factors are driving Ukraine's depopulation, chief among them low birthrates, high mortality, emigration, and tensions with Russia. The impact of low birthrates are heightened in Ukraine because medical care is less advanced and life expectancy is shorter than in many other developed countries such as Japan.

One is tempted to say that, if the Ukrainians don't start having children, they might as well simply hand over their country to Russia, since they obviously don't care enough to populate it.
