PRI Releases Planned Parenthood Organ-Trafficking Videos in Spanish

The struggle against Planned Parenthoods needs to go global—help us make it happen!

This summer, the Center for Medical Progress revealed to the world the deep-seated corruption pervasive in Planned Parenthood, one of the world's largest abortion providers. To date, ten videos have been released showing senior executives of the Planned Parenthood Federation of America (PPFA) at various stages in the process of harvesting and selling the organs of aborted babies.

Planned Parenthood, a taxpaverfunded organization that receives over half a billion dollars annually from the U.S. Government, is supposed to be dedicated to the health and welfare of women. But as many have pointed out lately, PPFA doesn't do

Parenthood does do is abort hundreds of thousands of unborn Americans every year. The Real Pope Francis Has Stood Up

It's time to take off the "Who am I to judge?" t-shirts.

For some time these have been flaunted by homosexual activists who thought that the Pope was giving them a pass. But it turns out that Pope Francis was not about to change Catholic teaching on marriage and sexual morality.

The real Pope Francis first showed up at the World Meeting of Families in Philadelphia, where he defended traditional marriage and childbearing in no uncertain terms.

At the "festival of families" he spoke of how "of this woman, Mary, and of this man, Joseph, a family is created into which comes God." Again in his closing homily, he emphasized "the word of the Lord [that] ... invites all those who want to share the prophecy of the covenant of man and woman, which generates life and reveals God!"

Memo to the U.S. Supreme Court: Marriage is a covenant between man and woman, which generates life and reveals God!

Relationships between two people of the same sex, which do not generate life and thus do not reveal God—whatever else they may be—are not marriage.

Then, at the United Nations, he said this:

"Without the recognition of certain incontestable natural ethical limits and without the immediate implementation of those pillars of integral human development, the ideal of "saving succeeding generations from the scourge of war" (Charter of the United Nations, Preamble), and "promoting social progress and better standards of


life in larger freedom" (ibid.), risks becoming an unattainable illusion, or, even worse, idle chatter which serves as a cover for all kinds of abuse and corruption, or for carrying out an ideological colonization by the imposition of anomalous models and lifestyles which are alien to people's identity and, in the end, irresponsible." [italics added.]

Anomalous, in Spanish, means abnormal. So what abnormal "models and lifestyles" is the Pope criticizing here? He's referring to the push by the UN to impose gender ideology, abortion, population control, and homosexual marriage on countries and peoples around the globe. His shorthand for this agenda of death and dehumanization is "ideological colonization."

The Pope's message on marriage was further reinforced by his not-so-secret meeting with the courageous Kim Davis, the embattled Kentucky county clerk who was jailed for refusing to issue marriage licenses to gay couples.

The mainstream media, angered by the Pope's obvious support for the county clerk, has tried to dismiss this as a "chance meeting."

But this supposedly "chance meeting" was arranged by Archbishop Vigano, the Pope's representative in the U.S., and took place at the Vatican's own embassy in Washington, D.C., to which the Davises were transported by Vatican security. Kim was even asked to put her long hair up in a bun so that she would not be as easily recognizable. Does this sound like an accidental encounter to you? As far as the meeting itself was concerned, the Pope offered specific words of

encouragement to Kim Davis in her fight. According to Liberty Counsel, when the Pope came in the room he stretched out his hands to Kim and encouraged her to "stay strong." He was obviously familiar with her case and wanted her to know of his prayers and support.

On his way back to Rome, Pope Francis—obviously referring to Kim

Davis—told reporters "Conscientious objection is a right that is a part of every human right. It is a right. And if a person does not allow others to be a conscientious objector, he denies a right. Conscientious objection must enter into every juridical structure because it is a right, a human right."

Reporters then pressed him on the question of whether that right included government officials like Kim, the Pope replied, "It is a human right and if a government official is a human person, he has that right."

Finally we have Pope Francis' address at the opening mass of the Synod on the Family, which constitutes a kind of *coup de grace* for those who thought that this Pope would fundamentally change Church teaching on marriage and divorce.

The Church's role, he said, is "to carry out her mission in truth, which is not changed by passing fads or popular opinions. The truth which protects individuals and humanity as a whole from the temptation of self-centeredness and from turning

fruitful love into sterile selfishness, faithful union into temporary bonds.

Covenantal marriages between man and woman are the very definition of fruitful love, since they are not transitory but permanent, and not sterile but open to life.

Sterile selfishness, on the other hand, is defined as contracepted sex, that is to say, acts that are by definition sterile and thus selfishly turn inward upon themselves. This is true whether the contraception occurs through chemical, surgical, or biological means (as is the case with two women, for example). Such acts, which are not open to life, have no end outside of themselves.

The Pope went on to quote Pope Benedict: "Without truth, charity degenerates into sentimentality. Love becomes an empty shell, to be filled in an arbitrary way. In a culture without truth, this is the fatal risk facing love" "(BENEDICT XVI, Caritas in Veritate, 3).

The media has deliberately misinterpreted the Pope's compassion towards individuals struggling with marital or sexual problems as a harbinger of fundamental changes in Church doctrine concerning marriage and sexuality.

At the end of the day, however, this Pope, like the 265 popes before him, will defend the Truth. He will say, as Cardinal Erdo did on the first day of the Synod, that while people in same-sex relationships need to be treated with respect and sensitivity, their relationships have nothing to do with marriage. He will affirm that Catholic marriages are indissoluble, and that those who have remarried outside the Church should ask Our Lord to come to them in spirit, rather than receive the Eucharist.

In the end, the Rock will not roll.

On our YouTube channel, https://goo. gl/LJfazn, you will find translations of the full videos originally published by the Center for Medical Progress as well as concise 3 and 1 minute versions that we have put together for viewers. These are faster to download and easier to "share" on social media then the full length videos.

Each video appears in three formats. For example, for the first video (where Deborah Nucatola is seen calmly discussing her killing techniques over wine and salad) we have a complete version, a 3-minutes version, and a 1-minute version.

Each video unveils a new level of corruption within the abortion business.

In the first video, Deborah Nucatola, Senior Director of Medical Services, can be seen sipping wine and eating salad while she describes how she obtains intact organs: "I'm going to basically crush below, I'm gonna crush above, and I'm gonna see if I can get it all intact."

Another shows the President of Planned Parenthood's Medical Directors' Council haggling the price of organs. "I want a Lamborghini," she says.

In another, a former Stem Express employee describes how she was forced to cut the brains out of a baby's head while its heart was still beating.

Now that PPFA's illegal organ sales have been exposed, they are starting to backtrack. The organization recently announced that it will no longer accept "monetary reimbursement" for procuring baby parts. Instead they will harvest the organs of babies for free! This is tantamount to admitting that they were earlier breaking the law. And it is still not "free," at least to the American taxpayers who pay hundreds of millions of dollars to

fund the evil empire of abortion.

Finally, there is the issue of informed consent. As the videos make clear, Planned Parenthood's employees routinely harvest the organs of their little victims without asking their mothers for permission. Isn't it the woman's body? We also see how abortionists modify the abortion procedure in order to obtain a better "specimen." We even hear them admit to performing illegal partial-birth abortions, where babies are delivered alive so that their organs can be extracted fresh and intact.

These women don't choose, and they don't consent. And the little girls and boys who are being butchered for their organs have no say at all.

A Modern Day Holocaust

Since *Roe v. Wade* abortion has claimed the lives of over 53 million babies in America. More than eight times as many infants have been killed through abortion than Jews murdered in the Nazi concentration camps. Abortion is truly the Holocaust of our time.

On May 2, 1945, the 8th Infantry Division and the 82nd Airborne Division liberated the Nazi concentration camp at Wöbbelin, Germany. There they discovered bodies that "were found piled four and five feet high," and others that were

strewn among the sick and dying.

Four days later, under orders of the 82nd Airborne Division, American troops forced the residents of the nearby town of Ludwigslust to walk through the camp and see what had been happening next door to their homes for years.

Nine days later, on May 15, Lt. Col. Ed Seiller

of Louisville, Kentucky, literally stood amidst a pile of Holocaust victims at one of the liberated Dachau subcamps and spoke to some 200 German civilians from nearby Landsberg whom American troops had forced to walk through the camp and see first-hand many of those who had died there.

How many of them had known about these camps? Seeing the horror first hand, they could no longer claim ignorance.

These vivid and sordid scenes come to mind when we confront the accounts and images of Planned Parenthood technicians sifting through the soupy remains of their abortion victims. These atrocious scenes happen everyday in abortion clinics nationwide.

Planned Parenthood alone slaughters over 325,000 children every year or at a rate of 37 every hour. But that isn't enough for them – after all, they were founded by a eugenicist, Margaret Sanger. For her acolytes, there's always more work to be done. The \$528 million that Congress gives to Planned Parenthood every year aren't enough to line the pockets of

this murderous organization. They won't be content until they can cut the brains out of babies as their hearts are still beating as a recent Center for Medical Progress video reveals.

The abortion rate in America has plummeted to the lowest levels since 1973. We now know how Planned Parenthood plans to make up for its lost profits—harvesting organs of aborted children and the more intact the better. If that means delivering a live baby before ensuring demise, so be it. If that means procuring baby parts without patient consent, so be it.

But Planned Parenthood is proud of their organ harvesting program. After all, it's for the sake of *life-saving* medical research.

Did I say "medical research"? Yes, that's the same term used by Josef Mengele, the notorious Nazi "Chief Physician" at Birkenau near Auschwitz. Every day, Dr. Mengele (a.k.a. the "Angel of Death") would sift through the incoming prisoners and select those he deemed most useful for his "experiments."

Holly O'Donnell, an ex-procurement technician for Stem Express (a

company allegedly involved in the purchasing of fetal parts from Planned Parenthood), recounts the zeal among some abortionists in harvesting baby parts. "If there wasn't a girl in the room [for an abortion], he would get mad. He would pace the hallways if there wasn't something to do," she says in the video.

One can only be reminded of accounts from concentration camp survivors describing Mengele's "frenzied attitude in carrying out his research...he seemed to have an inner compulsion to get a great deal accomplished quickly in a personal race against time."

Like Planned Parenthood, Mengele was obsessed with obtaining more "specimens" for his research. Eyewitnesses have said that he was always present at the train depot when inmates arrived (unlike the other doctors who took turns with the job). He would avidly search out twins for his "research." He would often be heard calmly whistling Wagner while choosing which subjects were fit for his experiments. Among those who were not selected for his research, he would decide in a glance who would become a slave laborer and who would be sent to the gas chambers. Mengele had a strong preference for the latter option.

Aside from Mengele's egregious and murderous violation of ethics, his "research" appeared to follow a methodology quite acceptable for his time. His "research" was academically rigorous, methodical and conducted with state-of-the-art medical devices and facilities—not unlike the "valid" research done with human fetal body parts as procured by Planned Parenthood.

Mengele would often perform dissections on twins after conducting research. In spite of his affectionate demeanor towards his patients during the course of a study, if he decided that a dissection would be beneficial he would often murder them himself.

One Nazi doctor was reported to have recalled an instance where "Mengele had shot [...] two boys in the neck and that, 'while they were still warm, began to examine them: lungs first, then each organ." These boys had been the favorites with the doctors and with Mengele himself.

But of course, as pro-abortion advocates would have us believe, that's completely different from ripping a baby from its mother's womb at 18 weeks gestation and cutting out its organs as his or her little heart is still beating...completely different.

Given the similarities between SS Dr. Josef Mengele and Planned

Parenthood's organ-harvesting business, it's no surprise that, after the war, Mengele became a renowned abortionist in Argentina. Of course, at that time, abortion was illegal in Argentina, but laws never seem to hinder the radical pro-abortion cadres.

The curtain has been lifted. The American public has seen first-hand Planned Parenthood's grisly abortion business as clear as the day when U.S. troops liberated the concentration camp at Wöbbelin. Yet to this day, Planned Parenthood continues to harvest baby parts.

And all of this for "life-saving" research—never mind the baby that is killed in the process.

The irony is absolutely sickening.

Below is a note in response from Joseph Morris, an observant Jew who served as an Assistant Attorney General in the Reagan Justice Department and as an American delegate to the UN Commission on Human Rights in Geneva.

"Some of my coreligionists are annoyed, or worse, when anyone likens any evil to the *Shoah*, which for some must forever be seen as *sui generis* and admitting of no comparisons. I agree with caution in the making of comparisons, but I disagree with such a categorical imposition of blinders, which can result, perversely, in moral obtuseness and even hybris.

The cry, "Never Again!", should be a normative stance, an imperative on which decent people are always resolute. (Right: "No future Holocaust, and nothing like the Holocaust, should ever be suffered again.")

It must not be allowed to define an empirical habit, one in which we adopt an *a priori* refusal to look evidence in the face. (Wrong: "Whatever an evil we witness may be, it cannot be as bad as the Holocaust, because, by definition, nothing could ever be as bad as the Holocaust.")

In truth, the *Shoah* was a crime and a criminal conspiracy that, in scope, motivation, and consequences, were sweeping, ghastly, and far beyond comparison with ordinary crimes and inhuman acts.

But some evils are, indeed, like the *Shoah* in material respects. Alas, measured by sheer numbers of victims; by the smugness, self-righteousness, lack of contrition, and banality of the perpetrators; and by the confoundingly blind eyes turned to the truth by much

of the rest of our putative civilization; the modern atrocity of industrial-scale abortion is similar enough to the *Shoah* that we should all be sickened; profoundly disquieted; and moved to humane action and the vindication of human rights."

The Challenge After the Synod

We live in historic times. Pope Francis came to the United States to preach the Gospel of the Family. Meanwhile, the major media, clueless about what it means to be Catholic, joined a peanut gallery of dissidents intent on turning the pope's visit into a celebration of sexual deviancy.

Fortunately, they failed. Millions welcomed the Pope as he encouraged all Americans to get married and stay married, and to reject the decadent, prurient pessimism of the popular culture.

When he returned to Rome, His Holiness inaugurated the Ordinary Synod on the Family. There 270 prelates from every time zone were met by a gaggle of professional agitators parading outside the Vatican, sowing seeds of heresy and dissent among a willing passel of paparazzi. Inside the Synod, bishops did their best to address the real issues, but the drumbeat of dissent was never far away.

During the Synod, Pope Francis addressed the dissenters head-on, warning that Satan is hard at work in the world: "When the devil manages to numb your conscience he has won a real victory," he said, because he "always tries to deceive" and to "make us choose the wrong path."

Funny, that didn't make it into *The New York Times*.

We might marvel at today's widespread hatred and rejection of Catholic moral teaching, but we must also recognize its aim: to hide the truth, to discourage the faithful, and to transmit to the world the message that the Church's teaching is as subject to change as a political party platform.

Behind this façade lurks a fundamental lie: "Yes, Church teaching might be true, it's just an ideal that is not achievable in the real world. So Christ must conform to the decadent culture, rather than calling the culture to 'be ye perfect, even as your Heavenly Father is perfect."

The dissident hubris is so noxious that one group of Rome's proud perverts actually proclaimed that "it is not what the Church can do for us, but what we can do for the Church that matters."

Imagine—the Church will be saved by sodomy!—but only if she abandons the Confessional and invites heretics to defile the Eucharist.

At the heart of this crude campaign is the rebellion against *Humanae*

Vitae. Satan and his hateful hordes know full well that Christ will protect the barque of Peter in the stormiest of seas so long as Holy Mother Church teaches and defends the truth. But they aim to sink her like the Titanic, using the lies of the sexual revolution as the iceberg.

Fortunately, the Synod's African bishops repeatedly pointed to the real challenge: the Church doesn't need to change her teaching; she needs to teach it better.

All God's people have a natural right

to the truth in all its beauty and purity. The Church's duty is not to change it but to teach it and defend it.

Archbishop Thomas Msusa told the Synod, "What is needed for us in Malawi is catechesis—teach young people to see married life as a vocation. It is a vocation; it is a call. And we have to be open really to the young people to work on them, just as the missionaries did."

Rejecting the catcalls of dissenters and their agenda, the Church must face real challenges: reversing the contraceptive mentality, calling on families to persevere in the midst of a hostile world, and caring for children of divorce, especially those growing up in fatherless homes.

FROM THE COUNTRIES

Australia

The Australian Family Association—Julian Porteous, The Archbishop of Hobart, was accused by LGBT transgender activist Martine Delaney of violating the Tasmanian Anti-Discrimination Act. Archbishop Porteous distributed a brochure entitled *Don't Mess with Marriage* to students of Tasmania's Catholic schools. The brochure explains the Catholic teaching on marriage and is the official brochure of the Australian Catholic Bishops Conference. It was given to students so that they might take it home to their parents.

"Section 17 of the Tasmanian Anti-Discrimination Act prohibits 'any conduct which offends, humiliates, intimidates, insults or ridicules another person' on grounds including sexual orientation and gender identity." Delany found the brochure offensive, and, citing Section 17, claimed the booklet to be "humiliating and insulting." Archbishop Porteous said he "believes [the complaint] represents a new intolerance against Christianity in Australian society, and more generally a threat to freedom of speech."

Spain

MercatorNet—In the Spanish territory of Galicia, there are at least 400 uninhabited villages for sale. The area is effectively dying, and immigration is not offsetting the decline in population. These abandoned villages are in large part

due to the area's shockingly low fertility rate. In Galicia, the fertility rate is just 1 child per woman, while the national fertility rates stands at a depressing 1.27 children per woman. All in all, there are over 3,000 abandoned villages in the country, an illustration of how population decline is changing the very landscape of Spain.

Does China's newly announced two-child policy mean a new dawn of reproductive freedom in China? "Hardly," says Steven Mosher. "It simply means that married Chinese couples will get a pass on a second child, but God help those who want to have a third."

China

The New York Times and

MercatorNet—On October 29th, Chinese officals announced the end of the one-child policy. In an attempt to boost the country's labor force and salvage their stagnating economy, all married couples now are allowed two children.

Last year, China's working age population (ages 15 to 64 years old) dropped by 1.6 million. In 2013, Chinese leaders relaxed the one-child policy in an attempt to raise the nation's birth rate. Couples were allowed a second child if either

parent was an only child. This change in policy did not result in the additional 2 million children per year that government officials expected.

However, Chinese officials may find it difficult to increase the country's fertility rate to replacement levels, since they "have spent the last 35 years bombarding them [their citizens] with propaganda that a big family is bad, wasteful, unpatriotic and against the law."

CNSNew—By the year 2050, the population of the United States is expected to increase by at least 100 million people. The U.N. predicts that the population will grow to 404 million, while the U.S. Census Bureau expects it to increase to, at most, 458 million.

By the year 2050, 20 percent of the population will be over the age of 65. Currently, that number is at just 13 percent. This means that by the year 2050, the U.S. will need a workforce large enough to support the 20 percent above the age of 65. As Bishop Paprocki of Springfield Illinoise aptly stated, "a lack of young people may pose a greater threat to the nation's well-being than population growth."

Due to the disastrous one-child policy, China's population is rapidly aging and the labor-force is shrinking, a trend which is hampering economic development. Jonathan Abbamonte, Research Analyst at the Population Research Institute, points out the policy's other damaging effects, "[the one-child policy has] resulted in an epidemic of sex selective abortion, forced abortion, and female infanticide since the early 80's. There are 116 boys born for every 100 girls in China with ratios significantly higher in some provinces," Abbamonte told gbtimes. "There are [also] an estimated 13 million more men than women between 20-34 years of age in China today." This excess of men will lead to increased sex trafficking and prostitution, Abbamonte stated.

Coalition—Population Research Institute has joined the Voice of the Family, an international coalition of Catholic laity. Voice of the Family was founded by the Society for the Protection of Unborn Children (SPUC) and LifeSiteNews (LSN) to offer the cardinals and bishops attending the Synod on the Family their almost 50 years of experience in pro-life and pro-family work. The Voice of the Family believes: (1) marriage, the exclusive, life-long union of one man and one woman, is the foundation of a stable and flourishing society, and the greatest protector of children; (2) the artificial separation of the procreative and unitive dimensions of the sexual act is a major catalyst for the culture of death; (3) parents are the primary educators of their children and it is through education and proper formation that the culture of life will be built.

SPLC.org—The Southern Poverty Law Center, a disreputable (but still influential) left-wing organization, recently released an article attacking PRI. Entitled, "The World Congress of Families (WCF) is one of the key driving forces behind the U.S. Religious Right's global

export of homophobia and sexism," the article defines a number of terms that partners of the WCF like PRI supposedly use to advance their LGBTQ agenda. They include the term "demographic winter" which supposedly "is used in reference to the notion that the human species is doomed to disaster because of an imminent and radical population decline." SPLC claims that this notion is led by "Demographic winter alarmists" such as the Population Research Institute.

"This is a curious assertion that we do not ascribe to," Says Research Analyst Jonathan Abbamonte speaking on behalf of Population Research Institute. "Contrary to the fear mongering of population alarmists, the world isn't heading for a demographic catastrophe," He continued. "According to the UN [...] world population is estimated to be 7.3 billion today. That number is expected to rise to 9.7 billion by 2050 and 11.2 billion by 2100. In the past two and a half decades, world population has increased by 2 billion people. Yet despite the rapid rise in world population, the percentage of people living with hunger in developing countries has actually dropped from 24% to 14% over the same time period. Welcoming another 4 billion to the human family, if that in fact actually happens, does not necessitate a demographic catastrophe."

China Announces End of One Child Policy

China Expert Steven Mosher Says Abuses Will Continue Under New Two-Child Policy

The Chinese government is apparently ready to loosen the stranglehold it has had on reproduction in that country since the late seventies—a little bit. Under the new policy, married Chinese couples will be allowed not one, but two children.

"The regime is backing away from draconian birth limits," says Steven Mosher, President of the Population Research Institute, "not because senior Party officials have suddenly developed a conscience. Rather, it will be because they have finally

realized that a shrinking workforce and a rapidly aging population are crippling future economic growth."

For at least the past two years, China's workforce has been shrinking. Last year, the potential workforce (ages 15 to 59) fell by 3.71 million, a significant number even by China's standards. At the same time, the over-sixty population is exploding. According to U.N. projections, it is expected to

more than double by 2050. China is growing old before it grows rich, and the strains on China's nascent pension programs will be enormous.

Mosher says, "Beijing now realizes that it must stop restricting childbirth and start encouraging it as soon as possible. Yet it can't simply abandon the policy altogether and admit it made a mistake. That would call the regime's legitimacy into question."

The parallels between China's current demographic and economic malaise and Japan's demographic

and economic decline in the 1990s is striking. The Japanese economy has never really recovered from its "demographic recession." China may not recover either.

The One Child Policy has caused fertility rates to plummet over the past three and half decades. Sex-selective abortion has reached epidemic proportions in many parts of the country. The strong preference for sons in Chinese culture, especially in rural areas, has resulted in the deaths of millions of unborn baby girls.

The overall loss of human life in China is staggering. China's own Ministry of Health estimated in 2013 that 336 million babies had been aborted as a result of the onerous population control program. With an estimated 13 million abortions taking place in China every year—almost 1,500 lives per hour—the number is likely significantly higher today.

Chinese President Xi Jinping first sought to loosen the policy in 2013. It was announced that couples were allowed to have a second child

following the birth of their first if either the husband or the wife was an only child. The response was underwhelming as few couples applied for a second birth "permit."

Mosher says, "Now couples are allowed to have a second child. But don't expect it to stop there. A government bent on controlling the fertility of its people will do whatever necessary to produce the number of children it thinks necessary."

After all, the One Child Policy is only one phase of the larger Planned Birth campaign. This is

Beijing's ongoing campaign to control the reproduction of the Chinese people under a state plan in the same way that it controls the number of tanks, or the number of coal-fired power plants, that it builds each year.

This means that, if the Chinese people refuse to conceive and bear the number of children that the state demands, childbearing will become mandatory. Women will be forcibly inseminated,

regular pelvic examinations will be instituted to monitor their pregnancies, and abortions will be forbidden.

Unless and until the Communist regime abandons its Planned Birth policy, and allows couples to freely choose the number and spacing of their children, abuses will continue.

And since when has a oneparty dictatorship ever voluntarily relinquished even a portion of the power that it wields over its people?
