# Victory over Radical Left's Culture of Death Is within the Grasp of Pro-Life Conservatives

Just when the Left was steamrolling us in the culture war, we look to have won a great victory.

According to the leaked draft of the Alito opinion, five of the justices of the Supreme Court have agreed that *Roe v. Wade* must go. Nearly a half-century after this infamous decision was handed down by their predecessors, the new conservative majority is going to send the matter back to the states.

Everyone has long recognized that *Roe*, in the words of my late friend Judge Robert Bork, "was a raw act of judicial tyranny." It invented a "right" to abortion out of whole cloth. Yet the Leftists had succeeded in quietly installing so many of their own on the highest court in the land that the vote was 7 to 2 in favor of the blatantly unconstitutional opinion.

They would not have succeeded if not for the inattention of Republican presidents. The story of Harry Blackmun, who wrote the poorly argued opinion, is a perfect illus-

tration of this. President Richard Nixon was unabashedly pro-life, yet he nominated Blackmun to the Supreme Court on the advice of Republican senators who assured him that Blackmun was a "conservative." After *Roe* came out, Nixon complained that he had been misled. Indeed he had been. Blackmun turned out to

be one of the most Leftist justices in American history.

The Left, knowing that most Americans are culturally conservative, pro-life, and pro-family, has for a century operated on the understanding that the easiest way to

### 2000 Mules, Hundreds of Thousands of Questionable Ballots, and a Stolen Election?

If the Party of Abortion is allowed to continue massively cheating in elections, any hope of ending abortion in the U.S. will vanish. Instead, they will legalize abortion up to birth and beyond throughout the entire country. Election integrity is a pro-life issue.

I have known about the efforts of Catherine Englebrecht and True the Vote to investigate the 2020 election for at least a year. And I have known for many months that the great conservative filmmaker, Dinesh D'Souza, was making a documentary about their efforts.

But seeing the actual film was still a revelation — for the work of True the Vote, as laid out by Dinesh, makes disturbingly clear that the 2020 election was probably stolen by Democrat operatives.<sup>3</sup>

By watching 2000 Mules you will learn how True the Vote plotted out on maps exactly where the mail-in ballot drop-boxes were in cities like Atlanta, Detroit, and Philadelphia, where massive voter fraud has long been suspected. They then put what they called a "geo-fence" around each drop-box.4

At the same time, they obtained terabytes of cell phone geo-tracking data in key swing states for the weeks before and up to the 2020 election. Running the geo-tracking data against the geofence coordinates, they then were able to see exactly which cell phones approached which drop boxes, and how many times they did so.

Those people who only visited the drop-boxes a few times, maybe dropping off a ballot for themselves, grandpa and grandma were eliminated. What was left were thousands and thousands of cell phone carriers who visited dropbox after drop-box, night after night, sometimes for days or weeks on end during the early voting period.

But the icing on the ballot trafficking cake came when True the Vote was able to get 4 million hours of video footage in some of these same states. They were then able to identify the cell phone carriers—True the Vote calls them "mules"—and observe their behavior. What they show—and what you see with agonizing clarity in the documentary—are ballot trafficking "mules" approaching a drop-box, usually in the wee hours of the morning, taking a handful of ballots out of a bag or backpack, and stuffing them in the ballot box. Over and over and over again.

You will leave the documentary convinced that this was a planned and coordinated conspiracy to add tens or hundreds of thousands of illegal ballots in every single battleground state. All together, True the Vote estimates that perhaps 7 percent of the mail-in ballots were trafficked. And, even using the most conservative estimates for how many mules stuffed how many ballots, they believe that, based on the evidence they've collected, the 2020 election was stolen.

So where do we go from here?

The first thing to do is watch the documentary for yourself. If you have already done so, then encourage your friends and family to watch it as well. No major news agency has carried news of 2000 Mules. There is simply no way to explain away the cell phone and video evidence of the Democratic party's illegal acts. And so they don't even try.

The conservative media has been largely silent as well. Aside from Tucker's interview with Catherine Englebrecht last week, Fox News has been silent on the 2020 election heist, and the documentary itself has gone unmentioned.<sup>5</sup>

And from the Republican Party's social media accounts—crickets. Its leaders in Congress, themselves safely re-elected, are afraid to confront those who have systematically

defrauded the American people of their true president.

As far as state and federal law enforcement agencies, they have taken no action to address the election heist either. True the Vote provided their data to the Georgia Bureau of Investigation last year, and nothing has been done. Perhaps not surprisingly, the FBI has not been on the case either.

It is impossible to exaggerate how precise the geolocation data for smartphones has become.

It would not be difficult for the FBI, or Homeland Security, to identify and interview each and every one of the mules pinpointed by True the Votes efforts. But, as far as we know, they have not even begun to do so.

So it is up to ordinary American citizens—you and me.

The documentary has been doing phenomenally well, but *2000 Mules* must do even better, so spread the word.<sup>6</sup>

Americans must raise such a cry that the Republican Party will find its voice, and law enforcement agencies will be forced to investigate.

If there are no consequences for the electoral fraud that Democrat operatives have perpetrated on the American people, they will do it again. And next time they will be even more brazen.

advance their agenda is through the courts. They carefully vet their candidates, making sure that they are judicial activists who are committed to their radical agenda. That's how they surreptitiously achieved their initial 7 to 2 majority.

They have been aided over the decades by moderate Republican senators-RINOs, if you will-who have refused to abide by the Party's pro-life platform. Instead, RINOs like Susan Collins of Maine or Lisa Murkowski of Alaska have repeatedly crossed party lines to vote for even the most radically pro-abortion nominees put forward by Clinton and Obama, even when those nominated were obviously unqualified.

Until recently, supposedly prolife presidents simply did not pursue control of the federal court system with equal vigor. It was not just that they did not impose a pro-life "litmus test" on their nominees, they barely pressed them on the issues at all. Instead, they were content to simply accept bland assurances from their nominees that they would abide by the US Constitution.

Certainly, the two Bushes, both Republicans and both at least nominally pro-life, were careless in their nominations, if not clueless. They often sought to avoid controversy by nominating supposed "moderates" to the court. That's how we got chameleons like Justice David Souter, nominated by the first Bush, who quickly joined the progressive wing of the court. And it was his son George who put Chief Justice John Roberts on the court. Although we were assured that Roberts was pro-

life, he has repeatedly betrayed the unborn in the years since and is now reportedly prepared to do so again: he is not joining the majority in overturning Roe v. Wade.1

As far as Senate Republicans, they, too, have all too often proven unwilling to hold the line. No Democrat nominee to the federal bench, much less to the Supreme Court, has ever been greeted by the Republicans with the kinds of vicious personal attacks that the Democrats routinely unleash on pro-life conservative nominees.

Some may remember that when President Reagan nominated Judge Robert Bork to the Supreme Court, he was so brutally attacked by the Party of Abortion that his surname became a byword for character assassination. When the Senate failed to confirm him, people said that he had been "Borked." They tried the same tactics on Justice Clarence Thomas a couple of years later. Thomas managed, with grace and character, to survive the Democrats' attempted "hi-tech lynching," as he called it, and won confirmation.

What ultimately changed the composition of the Supreme Court and put us on the cusp of a historic victory was-us. Through disappointment after disappointment, we in the pro-life movement never gave up.

More and more pro-life groups were organized at the state and local levels as the years passed, and hundreds of laws restricting abortion were passed by state legislatures and signed into law. The annual March for Life in Washington, D.C., continued to attract more marchers with each passing year and quickly became the longest as well as the largest continuing public demonstration in U.S. history.

As we mobilized and marched, we began demanding that self-declared pro-life politicians act on their campaign promises. We primaried and defeated RINOs who were unwilling to fight for the unborn. We rewrote the platform of the Republican Party to put it squarely behind the cause of life. And over time, we transformed the Republican Party—which at the time of Roe's passage was deeply divided on the question of abortion into the Party of Life. And we never ever accepted the idea that Roe was "settled law."

We created, in effect, a pro-life litmus test for every local, state, and federal office, up to and including the presidency. From President Reagan on, no Republican could hope to win his party's nomination for president without convincing the pro-life movement that he was pro-life.

That's why, when President Trump announced that he was running for the Republican nomination, one of the first things he did was reach out



What is not cause for celebration is that, for the first time in the history of the Supreme Court, a "draft opinion" has been leaked to the press.


This is not just a heinous breach of trust by a member, or members, of an organization that relies upon such trust and discretion to carry out its work.

# PRI's Ibero-American Director Unanimously Elected To IRTLF Board

The Board of Directors comprises twelve members: the President and one representative from each region. As of April 26, Carlos Polo now serves as the Board's representative from Ibero-America.

In 2012, Dr. Wilke was succeeded by Bradley Mattes, who founded the IRTLF with Dr. Wilke. Mattes tells the *Weekly Briefing* that a unanimous vote approved Polo's appointment to the Board of Directors by the Board members.

Steven W. Mosher, President of PRI, cheered Polo's appointment and said: "This is quite an honor. And it is also a recognition of the importance of Carlos' ongoing contribution to the Culture of Life throughout what we are now calling the Ibero-American region. May God continue to bless your efforts on behalf of Life, Carlos! We are all proud to be associated with you."

Carlos Polo is a leader with a long history of efficient pro-life work. In virtually every major pro-life battle of the last twenty years, Carlos has played a role, often behind the scenes, as he assisted other Ibero-American groups, contributing his experience and expertise. No group in Ibero-America has not received his visit or help at one time or another. He has now expanded his efforts to help allies in Europe and beyond.

Polo's work in recent years has focused on creating analytical and strategic tools that enable pro-life leaders to improve their skills. A Peruvian native, Polo and his wife Maria Elisa have three children on earth and two in heaven. After working as a consultant in the private sector for several years, he has dedicated himself entirely to promoting the pro-life cause for more than two decades. His university degree in Social Anthropology has contributed to his keen understanding of the relationship between people's daily lives, politics, and the pro-life cause.

In addition to directing the PRI Office in Latin America, Polo is a member of the Board of CitizenGO, a digital platform with more than 17 million members that coordinates citizen activism in 12 languages. He

## Dobbs Sets the Stage for a Historic Election

This November's elections will mark a critical turning point for pro-lifers.

Motivated as never before, defenders of the unborn will be active nationwide — this time, concentrating on the state and local levels.

That's because, for the first time in 50 years, candidates who win state legislative races will once more be responsible for exercising the "Rights of the States and of the People" — rights guaranteed by the Tenth Amendment to the Constitution.

In the case of abortion, those rights have been arbitrarily denied by the Court's lethal 1973 decision in *Roe v. Wade*, which the Supreme Court has now found to be unconstitutional.

The *Dobbs* decision offers us a historic opportunity. It represents a wake-up call that millions of us have been praying for since 1973.

While the door is now open for states to exercise their rights protected by the Constitution, the path will not be clear sailing for supporters of life.

We have a lot of work to do.

## Beware of the Schumer Standard

In May, the Guttmacher Institute identified twenty-six states that are "certain or likely" to pass legislation banning abortion once *Roe v. Wade* is overturned.<sup>1</sup>

As PRI President Steve Mosher makes clear in this issue, pro-abortion forces nationwide will act with laser-beam focus to advance their cause in every possible way. And we should take their threats seriously: in their view, the Supreme Court "broke the law" when it overturned *Roe*. Why should they *follow* the law in their efforts to restore it?

The demand for pro-abortion violence resonates with the threat leveled by Senate Democrat Leader Chuck Schumer on March 4, 2020: "I want to tell you Neil Gorsuch, and you Brett Kavanaugh," Schumer shouted in front of the Supreme Court at a pro-abortion demonstration. "You have unleashed a whirlwind, and you will pay the price," he continued.<sup>2</sup>

"You won't know what hit you if you go forward with these awful decisions," he threatened.

This May, the pro-abortion "Women's March" demanded a "Summer of Rage" if *Roe* were overturned.<sup>3</sup> Their threat of violence was no joke: we recall how the massive riots, violence, and destruction during the summer of 2020 destroyed dozens of lives and thousands of livelihoods. Activists led by the anti-family, pro-abortion Black Lives Matter group — founded and led by an avowed Marxist — declared that law enforcement was the enemy.<sup>4</sup> In the ensuing carnage and chaos, thousands of violent crimi-

nals nationwide escaped arrest and punishment.

"Raise Hell, no sweat" — that was 2020's message for today's pro-abortion radicals.

#### Know the Enemy, Be Prepared, and Pray!

Students of the Left know that its violence does not merely represent an outburst of frustration that will soon diminish when things "return to normal."

Rest assured, for the Left, chaos *is* the "normal." Its threats and the accompanying violence are designed to intimidate, attract new recruits, and create and perpetuate chaos. These factors are designed to discredit and weaken respected institutions while intimidating those who defend them — and ultimately to defeat them, and destroy them.

And one of the most vital institutions to the survival of our Republic is the integrity of free and fair elections.

The outcome of this November's elections will determine the makeup of 88 state legislative chambers in 46 states. Over 6000 seats will be in play.

Will they be peaceful?

We note that when demonstrators gathered illegally at the family residences of several Justices supporting the draft of the Court's majority opinion in *Dobbs*, Attorney General Merrick Garland allowed

to the pro-life movement. Then in July 2016, he invited several hundred of us to New York City to ask for our support and find out what actions we would expect him to take on behalf of the unborn if he were elected president. At the very top of our list of pro-life priorities, we made clear to him, was putting pro-life judges on the federal bench and, if the opportunity arose, on the Supreme Court. He assured us that he would.

Trump kept his word. For four long years, he nominated hundreds of pro-life federal judges who will be on the court for decades to come. The radical left did their best to "bork" many of his nominees, but they failed in almost every instance, in large part because Trump not only made excellent choices but backed them to the hilt. The attacks reached a crescendo with the attempted personal destruction of Brett Kavanaugh, but Trump never wavered.

Trump's Supreme Court nominees—Neil Gorsuch, Amy Coney

Barrett, and Brett Kavanaugh—joined by Justices Clarence Thomas and Samuel Alito, comprise the Magnificent Five, who will soon release their historic opinion.
