



How Many More Epidemics Will China Help to Spread?

For over two years, we have lived through a pandemic that no one — no one who doesn't fall for Communist Chinese propaganda anyway — doubts came from China.

In fact, the consensus now is that COVID came from the Wuhan lab, something I wrote about in these pages at the outset of the outbreak. In recent months, many of those who had earlier parroted Beijing's line about COVID coming from a bat cave, including China's man at the World Health Organization, Dr. Tedros Ghebreyesus, have come over to my point of view.

At the same time, there is mounting evidence that the coronavirus was developed as part of China's bioweapons program.

But, leaving all this aside, there is no doubt on one key point. The Chinese Communist Party has a long history of covering up epidemics within China, and then carelessly —



or deliberately — allowing them to spread around the world.

The fall of 1957 saw an outbreak of what came to be known as the Asian Flu. It was first reported in the cities of Singapore and Hong Kong, but this new and deadly influenza soon went global.

China played no role in its creation — in this case the offending virus truly did have a natural origin

— but it certainly did play a role in its spread. The new flu had arisen in the interior province of Guizhou in early 1957 and had spread throughout China in the months following. But even as tens of thousands of Chinese lay dying, the epidemic was kept hidden from view by the Communist authorities.

Thanks to the courage of three Trump-appointed Supreme Court justices, and the heroic Justice Clarence Thomas, *Roe v. Wade* is history. As Justice Sam Alito wrote about this raw act of judicial tyranny:

“The Constitution makes no reference to abortion, and no such right is implicitly protected by any constitutional provision. ... Wielding nothing but ‘raw judicial power,’ the Court usurped the power to address a question of profound moral and social importance that the Constitution unequivocally leaves for the people.”

Now the question becomes, “Where do we go from here?”

Many states are already moving forward. A dozen already had “trigger laws” in place that will now ban or significantly restrict abortions now that *Roe* is gone. According to the pro-abortion Guttmacher Institute, fourteen more states either have or will soon consider, restricting the murderous procedure. I would add North Carolina, where I recently spoke, to that number.

Abortion clinics are going out of business, with some 40 or so already announcing they are closing their doors.

But we must do more. In states that do not yet ban abortion, we must work with pro-life state legislators to protect all human lives. Where a complete ban is not possible, we must advocate

for Heartbeat legislation, that will prevent all abortions after six weeks, understanding that this is only a way station on the way to a complete ban. One way to assist this effort is to sign our petition here.

We must force the other side to defend the indefensible killing of the innocent unborn by waging a digital war. Everyone should be using their own social media apps (if you have one) to share pro-life content, such as ultrasound pictures of babies in the womb! The battle for Life, like the battle for Heaven, is won one soul at a time!

At the local level, talk to your city councilman or county supervisor about making the place where you live

a sanctuary for the unborn. Outlawing abortion within city or county limits is possible even in hostile states like New York or California if you happen to live in the more socially conservative parts of these states.

Even closer to home, support your local crisis pregnancy centers, whose services will now be more in demand than ever before from young women who have nowhere else to turn. I myself serve on the boards of several such centers. Volunteer if you can, donate if you can't.

Finally, we can't forget how we reached this point, through decades of fasting, prayer, and political involvement. Pro-life Americans must storm the polls in overwhelming numbers this November to ensure that our newfound gains are not turned back. The time to recruit and register new voters who will vote to preserve and expand protections for Life is now.

How many more epidemics?, *continued*

When infected travelers from China later carried it to Hong Kong and Singapore, the World Health Organization and other public health authorities were caught flat-footed. Thanks to Beijing's perfidy, quarantines and vaccines came too late. Before the Asian Flu had run its two-year course, it had killed well over a million people.

The same scenario played out again ten years later. In 1968, an unknown influenza had quickly spread throughout the world. It came to be known as the Hong Kong Flu, infuriating that city's Chamber of Commerce, the members of which knew quite well that an epidemic was raging in Mainland China just across the border. Once again, the Communist authorities had refused to alert the world, and another million people died.

China continued to play "hide the virus" when the SARS epidemic broke out in 2002. Patient Zero was a snake seller in China's Guangdong province who came down with the disease on Nov. 16, 2002. He died shortly after that, and hundreds of other cases were soon recorded by Chinese health officials.

But the Communist regime lied about the disease for months, silenced whistleblowers, doctored data, duped global health authorities, and even accused "outside forces" of carrying out a "bioterrorist" attack.

Sound familiar?

They did not inform the WHO about the outbreak until February 2003, three months later, and only after Canadian intelligence had already detected and publicly report-

ed on a “flu outbreak” in progress in China.

SARS — short for “severe acute respiratory syndrome” — was a viral respiratory illness caused by a coronavirus. It had the highest case fatality rate of any influenza since the Spanish Flu. Eleven percent of those who came down with SARS died.

Like the Spanish Flu, SARS could easily have killed tens of millions worldwide had the Canadians not forced Beijing to reveal its existence before it had spread outside of its borders. Its containment was aided by the fact that, while it was highly infectious, it was not airborne. As a result of its early detection and relatively low transmissibility, by the time the SARS epidemic ended in June of 2003, there had been a total of only 8,469 cases reported.

But the lethality of SARS impressed China's bioweapons experts, and they began discussing how to genetically engineer a SARS-like coronavirus that could easily be transmitted from person to person. The kind where a single sneeze can infect an entire roomful of people.

In late 2017, a Chinese researcher named Dr. Shi Zhengli, with

the help of British zoologist Peter Daszak of EcoHealth Alliance, a beneficiary of US government funding and an ally of Dr. Anthony Fauci, traced the original SARS virus back through an intermediary host to the original carriers: the cave-dwelling horseshoe bats of Yunnan province.

The rest is history.

Somewhere in China, perhaps even at the Wuhan Institute of Virology itself, they are even now genetically engineering new “unrestricted bioweapons.” Anyone who thinks China's biotechnology labs are going to be used for noble scientific purposes is committing the same fatal error that Dr. Fauci did.

Another plague — again from China — is almost certain to hit us in our lifetimes. Indeed, the very bioweapon that will be used may already be lurking in a test tube somewhere.

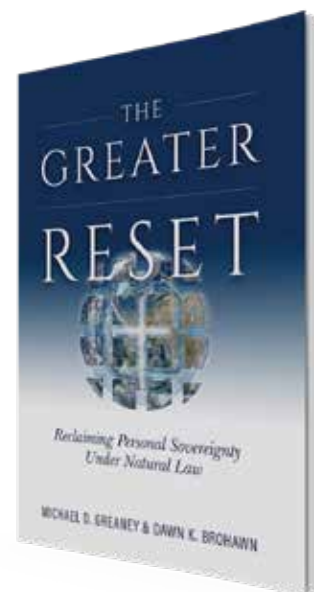

Beware of Treaties Bearing Gifts

The World Health Organization (WHO), the “specialized agency of the United Nations responsible for international public health,” is planning a Pandemic Treaty that would bestow unprecedented worldwide power on the unelected organization.

Tedros Adhanom Gebreyesus, Director General of the WHO, is a lackey of Communist China. After his January 2020 visit with Chinese dictator Xi Jinping, he obediently refused to blame China for covering up the virus outbreak in Wuhan. A Pro-Life President, Congress, and Nation

Guatemala is a small Central American country with deep Christian roots, so the protection of life runs deep in its culture.

However, for decades USAID has imposed radical “reproductive health” and “family planning” programs on Guatemala to make the country an example to the world.

For USAID officials, Guatemala’s Catholicism and its cultural values were always seen as “barriers” to be removed.

In recent months, a chain of events has confronted this negative influence. Guatemalans now have a president who courageously defends their sovereignty in the face of international pressure to legalize abortion; a Congress that joins him

in that opposition, and citizens who not only support them but celebrate their convictions.

Undoubtedly, Guatemala today offers a very inspiring testimony.

On June 28, 2022, Guatemalan President Alejandro Giammattei went to the Organization of American States (OAS) to denounce international efforts to force his country to grant legality to the legal murder of unborn children.

In its Annual Report 2021, the Inter-American Commission on Human Rights (IACHR) demanded that Guatemala adopt “legislative measures, public policies and any other necessary measure (...) to guarantee women’s access to sexual and reproductive health goods and services

without discrimination, including access to voluntary interruption of pregnancy in cases of danger to life or health, as well as in cases of rape and incest”.

For the President of Guatemala, this Commission “reveals an agenda in favor of abortion that exceeds [the Commission’s] competencies, because the IACHR should not be an activist on these issues, but respect the sovereignty and freedom of each State to decide on these issues.”

Giammattei also showed a video sent by the Guatemalan Congress presenting evidence of repeated intrusions in the internal democratic processes in his country. The excess-

es not only demanded abortion regulations but prevented pro-family legislation. As legitimate representatives of the Guatemalan people, the parliamentarians reminded the OAS that its role should not infringe on the sovereignty of nations.

To make it clear that Guatemala is not alone, Giammattei cited the June 24 U.S. Supreme Court ruling that overturned the supposed “right” to legal abortion. He also clarified that the OAS only pressures small countries and will not have the same demands with the US.

This story began on October 12, 2021, when President Giammattei signed the “Geneva Consensus to Promote Women’s Health and Family Promotion.” Precisely, there it is stated that there is no “right” to abortion. Of course, on that day, the international abortion lobby made Guatemala its target.

Five months later, despite a ruthless international media campaign against it, Guatemala reaffirmed its pro-life position. On March 9, 2022, Shirley Rivera, president of the Congress, and deputies from different parties participated in the act where Guatemala was declared “Pro-Life Capital of Iberoamerica.” President Giammattei and all his ministers were also present. Afterward, the inauguration of the Patio de la Vida was held at the National Palace of Culture, where a monument for Life and the Family was unveiled in the presence of national and international authorities.

PRI has not been unaware of this work. Sergio Burga, manager of the PRI Office for Ibero-America, was last June offering conferences in 10 major cities. Pro-life deputies and the AFI Coalition brought together hundreds of citizens to implement a Conservative and Pro-Family Agenda to confront the threats of the globalist pro-gender and pro-abortion agenda. This massive turnout will have a political impact which shall be reflected in next year’s presidential and congressional elections.

The pro-abortion and LGBT lobby has nightmares imagining the next administration continuing along these lines.

Every true pro-life activist longs for a world with total respect for life from conception, in the written law, public policies, and in the discourse of its authorities.

Guatemala has taken crucial steps in this direction.

Teresa tells me that she is receiving more applications from clinics and hospitals all the time. Our process is highly selective: only Catholic hospitals and clinics that guarantee the machine will be used to save babies, receive our assistance.

CHINA

China's Population Decreases while India's Increases

China's population rates are dropping at an alarming rate. Within the next five years, India is predicted to have the largest population — even now that China is desperately trying to increase its population after realizing that the one-child policy was a bust. “The Chinese birth rate fell to 7.52 births per 1,000 people in 2021, the lowest level on record and a 12% decline from the year before. Only 10.6 million babies were born in China in 2021, a 11.5% drop from the year prior.” It is estimated that China's current population is 1.426 billion, while India is close behind at 1.412 billion.



EUROPE

Abortion Voted to be a Fundamental Right

The EU parliament voted on Thursday, July 7th, “in favor of a resolution calling for the right to abortion to be included in the EU Charter of Fundamental Rights.” The vote was 324 in favor and 155 against the proposition. After seeing America overturn *Roe V Wade*, they are shaking in their boots, fearing that the same results might happen in the EU!
