



The Death Peddlers: Kamala Harris and Tim Walz

A few years ago it would have been unthinkable to make abortion—the death of unborn children—the centerpiece of a presidential campaign.

But that’s exactly what the Harris-Walz campaign is doing.

It’s not just that they have abandoned former President Bill Clinton’s “safe, legal, and rare” formulation and embraced the “right” to kill an unborn baby for any reason, at any time, up to and including the moment of birth—and even after birth, should the baby survive the abortion.¹

That, sadly, is now the position taken by all leading Democrats.

But Harris-Walz have gone even further. They have elevated this “right” above all others, including those listed in the Bill of Rights.

Abortion is, according to Vice President Kamala Harris, “a woman’s most fundamental right,” meaning that in her view it trumps freedom of

speech, freedom of religion, or even freedom of conscience.²

But it’s even worse. Not only do the two support zero limits on abortion, they want to overturn pro-life laws in dozens of states and impose their radical views on the entire nation. They want to increase funding for Planned Parenthood and shut down crisis pregnancy clinics.

Democrats like Joe Biden used to speak of abortion with a tinge, per-

haps contrived, of regret. But Kamala Harris has dropped the pretense. She actually celebrates the act of stopping a beating heart, as when she gave a shout-out to Arizona Senator Eva Burch for “bravely sharing her story” of how she would be having an abortion.³

On that same national abortion tour we also saw Harris, in a first for any national candidate, campaign at

The Left Lusts to Destroy Life, Family and Faith?

That's what the Opening Ceremony of the Paris 2024 Olympics was all about

If you are like me, you were appalled by the Opening Ceremony of the Paris 2024 Olympics. Drag queens mimicking Leonardo da Vinci's painting of the Last Supper have nothing to do with sports and everything to do with mocking Christianity.

This blasphemous performance was not an isolated incident, but part of a long pattern. "Progressivism" or "wokism" is a modern-day adaptation of atheistic Marxism that aims to destroy Christianity, and with it Western Civilization.

Such attacks on our faith and values happen every hour of every day. They occur in schools, libraries, movies, music, TV shows, books, public squares, awards, painting, sculpture, nightclubs, museums, parliaments, ministries, hospitals, NGOs, and more.

The Paris blasphemy set off all alarms only because of its reach: It was broadcast simultaneously on hundreds of millions of TV screens around the world.

This was a big scandal, but it's in a myriad of small things that our Western culture is being destroyed. Because we don't get outraged by the small things, the evil has invaded our living rooms.

It's no coincidence that children were used in this mockery. For over

100 years, cultural Marxism has been on the march. It has focused in succession on killing God (atheism), then on killing the father (rejection of authority), and from there on killing the mother (radical feminism and abortion).

Now it's after the child. And it wants them isolated from their parents and alone, so they can be more easily indoctrinated by the State. The "woke" view of children is that they are no longer sons or daughters, but junior "citizens"—creatures of the State whose only important "rights" are sexual and reproductive.

The main means of achieving this nefarious plan is what is called "Comprehensive Sexual Education."

Now, this is not to be confused with education, or even true sexual education. Rather, it is a carefully designed propaganda course in gender ideology. It teaches children (!) that they have an inalienable right to have sexual relations—even with adults—as long as these are "consensual, safe, and pleasurable."

It encourages them to have sex without love and without responsibility, even without the knowledge and consent of their own parents. It tells them they have an absolute "right" to contraception and abortion. And it tells them that their parents have no right to interfere with, or even know about, any of these activities.

Spanish journalist Álex Rosal, in his book "Wake Up and Fight the Barbarians Who Ruin Your Life," asserts that "wokism" has advanced only because

an actual abortuary in Minnesota. She grinned and cackled through her speech as usual, ignoring the fact that the very ground she was standing upon was soaked with the blood of thousands of innocent victims.

Even Hitler, as he implemented his Final Solution, never visited his death camps, nor did he speak openly about them, afraid to admit publicly the evil he was secretly about.

Not Kamala. In the weeks since Harris replaced Biden at the top of the Democrat picket, we've learned more than we ever wanted to know about Kamala's radicalism on the issue of abortion.

At a time when American birth rates are at historic lows, Kamala wants to drive down the birth rate even further to stop "population growth."⁴

At a time when even China has decided it wants more—not fewer—babies, Kamala thinks it makes sense that young people should avoid having children because of "climate change."⁵

Given all this and more, it didn't seem possible that Harris could pick a running mate who is even more radical than she is on the abortion issue.

But in Minnesota Governor Tim Walz she seems to have found one.

Walz Lied About China's One-Child Policy

One troubling sign is that Tim Walz has deep connections to the Chinese Communist Party and is an admirer of the Communist regime. He has traveled to China thirty times *on China's dime*. This is the very definition of a fellow traveler.⁶

This means that, unlike Biden, Walz' connection with the Communist Chinese is more ideological than financial. This, in my view, makes him even more a danger to American liberties.

While he has criticized the 1989 Tiananmen Square massacre in which 10,000 or more Chinese students were deliberately killed by the Communist regime, he pointed to the clash at Wounded Knee a century earlier, as if to say that America was no better.

Even more troubling, he was in China during the heyday of China's now defunct one-child policy, which involved forced, late-term abortions and even infanticide. But instead of

condemning it, he did everything in his power to justify it.

The one-child policy was necessary, Walz said, because "the Chinese population was so large." He also falsely claimed that the only consequence of having more than one child was that "the family pays a tax."⁷

In fact, throughout the time that Walz was making repeated visits to China, women were being hunted down for the "crime" of being pregnant without permission, and were being taken by force to abortion centers. I know. I was there.⁸

Taking a leaf out of China's book, as governor Walz overturned a Minnesota law making it a crime to force a woman to get an abortion.

In other words, as governor he not only endorsed abortion up to birth, he gave free rein to men to coerce women into unwanted abortions when they are at their most vulnerable, emotionally and financially.

Echoing Pete Buttigieg, Tim Walz thinks that abortion has been a good thing for men. It certainly has for some, since it enables them to avoid taking responsibility for getting a young woman pregnant.

And both of them want us to pay for abortions and shut down those who offer alternatives.

Kamala Harris and Tim Walz are—to borrow a phrase from the late, great Father Paul Marx—death peddlers.

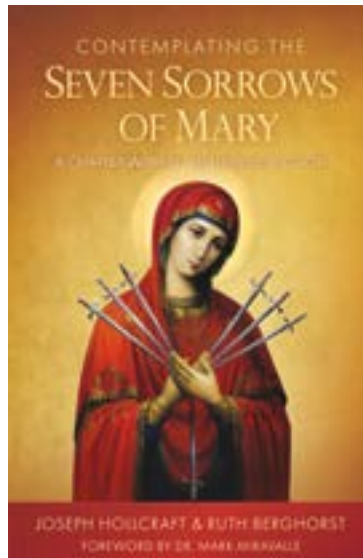

Massachusetts Wants To Make The Family Illegal

Years ago, when I served as the faculty advisor to the Boston University Students For Life, we joined pro-life groups from dozens of local colleges and universities to encourage women, mostly students, to choose life when they experienced an unplanned pregnancy.

At times this was a challenging task: Massachusetts is one of the most pro-abortion states in the country, and the mood on the campuses there is no different.

Fortunately, many Bostonians are prolife – and they’re strong because they know they’re going against the grain. That means that many doctors, nurses, and neighborhood groups are willing to help these young women to bring their babies to term.

Occasionally they help to place newborn children in adoptive homes as well.

That was often a daunting task – the peer pressure surrounding young college girls is hardly supportive of the culture of life. After all, most of these kids have been drilled with the “the right to choose” mantra since grade school. The result was a public view of abortion that harmonized with the “Culture of Death” that Saint John Paul II recognized in America a quarter-century ago.

So those Bay State mothers who choose to place their child in a Catholic home have an even steeper mountain to climb. In fact, Massachusetts has made it virtually impossible for Catholic families to adopt them.

To Boston’s shame, “Catholics Need Not Apply” – those signs so often seen in centuries past – have now reappeared. If you’re a faithful Catholic seeking to adopt a child in Massachusetts, you’re out of luck.

Families Need Not Apply, Either

The Bay State’s war on the family has scored another victory. This past August, the Massachusetts Legislature adopted a measure that eviscerates language, nature, and reality itself – all in the name of “love.”

The “Massachusetts Parentage Act” demeans every man and woman, every mother and father, to please a tiny minority of lesbians and homosexuals. These activists, who fifty years ago were pleading to be left alone, have now decided that it’s our turn.

They were once called “queer,” “effeminate,” even “perverted.” But that was then. Today, proudly riding atop the crest of the wave of the Culture of Death, they are now in command.

With this new law, Bay State parents of newborn children are no longer permitted to call themselves “father” and “mother” on official documents. In classic Orwellian fashion, the destroyers have demanded that the family bow to their destruction of language.

In a laborious 42-page document, a unanimous Massachusetts legislature has put every term in family law referring to marriage, family, and

natural childbirth on the chopping block

In the name of “legal parentage equality,” birth certificates in the Commonwealth are now required to replace the terms “man” & “woman” with “persons” and replace “mother” with “person who gave birth.” “His” and “her” must now be rendered as “their,” but that use of “their” allows the involvement of a “surrogate mother,” legally allowed to be paid for bearing her child; should she object to being deprived of her baby, “[T]he court may adjudicate a child to have more than 2 parents if the court finds that it is in the best interest of the child.”

Before long, “husband” and “wife” will undoubtedly join “father” and “mother” in the Massachusetts trash bin.

Get ready: “I now declare you spouse and spouse.”

Many Catholics supported the legislation. Their position was best represented by Catholic Governor Maura Healy after she signed the legislation:

“Parents and their children know that love is what makes a family. It’s time our laws and language recognize that too. From marriage equality to parentage equality, we’ve never been a state that lets anything stand in the way of love.”

Right out of Big Brother’s Ministry of Love – which, as we recall, was a torture chamber.

The Republican Party—and Donald Trump—are still Pro-Life

On July 15th, delegates to the Republican National Convention in Milwaukee adopted a platform that stakes out a new position on abortion.

The document echoes the view of its standard bearer Donald Trump:

“We believe that the 14th Amendment to the Constitution ... guarantees that no person can be denied Life or Liberty without Due Process,” it affirms, “and that the States are, therefore, free to pass Laws protecting those Rights. After 51 years, because of us, that power has been given to the States and to a vote of the people.”

Many pro-life leaders have signaled support for the new platform, including Marjorie Dannenfelser of the Susan B. Anthony Pro-Life America, who wrote, “It is important that the GOP reaffirmed its commitment to protect unborn life today through the 14th Amendment. Under this amendment, it is Congress that enacts and enforces its provisions. The Republican Party remains strongly pro-life at the national level.”

Not everyone agrees, of course. Live Action’s Lila Rose claims that the platform change will “alienate some of his most passionate supporters and will win exactly zero fence sitters.”

I believe this is a misreading of the political moment we find ourselves in.

Committed pro-lifers—among whom I count myself—understand that *Dobbs v. Jackson Women’s Health Organization* was a legal earthquake that radically changed the political landscape.

The good news is that fourteen states now have total bans on abortion. Twenty-seven other states ban mid-term or late-term abortions. More and more babies are alive today—some 130,000 at the latest count—who would otherwise have suffered a brutal death.

But while pro-lifers celebrated—and perhaps grew a little bit complacent—those who favor abortion under any and all circumstances are angry and energized, not to mention increasingly well-funded and organized. They are working hard to make the November election a national referendum on abortion.

And why wouldn’t they? Since *Dobbs* became the law of the land, there have been seven state referenda on abortion, and in every single one of them—even in Deep Red Kentucky—the pro-aborts have prevailed. “Freedom” and “liberty” and the “right to determine one’s own life course” were the deceptive synonyms used for unchecked abortion, and the individualistic impulse common to all Americans did the rest.

Because of their recent successes—and because they literally have no other issue to run on—the Party of Abortion continues to double down. They want abortion without limits and they are willing to use the full power of government against anyone who stands in the way of their radical aims.

Kamala Harris, who has replaced Biden as the Democratic nominee, goes around lying that “Donald Trump would ban abortion nationwide” when he has specifically said that he would not. The administration of which she is a part not only classifies pro-lifers as potential terrorists, but is also actually trying to terrorize them, arresting sidewalk counselors for imaginary crimes and throwing pro-life people into prison.

None of this is to say that the Republican Party or its latest platform is perfect. While the pro-life movement, for many decades, has been allied with the Republican Party, it has not always been an easy relationship. Only about half of Republicans share the view of pro-lifers like myself, that there is no cause greater than life.

But the upcoming election is no longer about whether we can protect all babies, but whether we can protect any at all or, indeed, our very Republic. The Democrats are determined to crush the pro-life movement one way or another in the same way their abortionist allies crush the life out of unborn children. The Republicans will support our efforts to advocate for and protect the unborn in the fifty states, as well as the fundamental freedoms that allow us to do so.

We have reached a point in our nation’s history where the fate of America’s children is strangely tied to the fate of America itself as a constitutional republic.

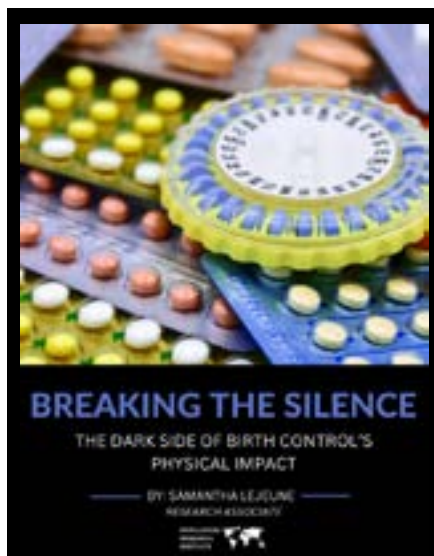

Benefits in the U.K. Capped After Two Children

The U.K. Labour Party's "two-child benefit cap" is back in the spotlight. This controversial policy prevents parents from claiming universal credit or child tax credit for a third child, with a few exemptions. Withholding these benefits, which help offset the costs of having and raising children, contributes to poverty in larger families. This benefit cap is most likely also a contributor to the below replacement fertility rate in the U.K. as couples struggle to afford more than one or two children. As of April 2024, 450,000 families were negatively affected by this benefit cap. Unfortunately, Prime Minister Sir Keir Starmer has stated that this policy will not change until there is an increase in economic growth.¹



CHINA

China is Facing Severe Population Decline

The UN's World Population Prospect 2024 report had some serious implications for China. The report's predictions found that China's population could be halved by the end of the century. The country's population is currently ~1.4 billion, but China could be back to its 1950s level of ~700 million people by 2100. This decline is due to the decrease in mar-

riage and childbearing in the last few decades, both massively affected by the one-child policy. The bulk of this coming population decline is predicted to occur between 2024 and 2054, with an estimated drop of ~204 million in that time frame.

"Chinese official statistics are always fabrications, exaggerating the good and lowballing the bad numbers is standard practice among Chinese officials," said Mr. Mosher. "China's population is overstated by at least 100 million people, which means that the aging and dying of China's population will occur even more rapidly than many predicted. Communism always kills, sometimes it kills slowly and sometimes it kills quickly, but it always kills."

"The Chinese Communist Party, in imposing the one-child policy on the Chinese people, has condemned China to senescence and death," continued Mr. Mosher. "China under the CCP will never be the world's dominant superpower."²



INDIA

Is a Two-Child Policy Coming to India?

A two-child policy may be coming to India. An NGO called the Jansankhya Samadhan Foundation (JSF) has been calling for a two-child policy across India for years. This year, on World Population Day (July 11), the JSF arranged an event where its president renewed this call once again.

The JSF wants the introduction of a strict system of population control that limits couples to two children, with punishments for violators including up to 10 years in jail and/or the termination of government positions. For any "surplus children" born, the JSF recommends the non-issuance of birth certificates. The organization has already submitted a memorandum to Indian Prime Minister Narendra Modi urging him to accept the proposed two-child policy legislation.³



POLAND

Poland Parliament Rejects Anti-Life Bill

The lower house of Poland's parliament has narrowly rejected a bill aimed at liberalizing the country's abortion laws by a vote of 218-215. The proposal aimed to eliminate penalties for abortion providers, including providers of the abortion pill and doctors performing early-term or fetal anomaly-related abortions. In 2021, Poland passed a ban on almost all abortions with exceptions for cases of rape, incest, or when the mother's health or life is endangered. However, last year, Prime Minister Donald Tusk's Civic Coalition party previously promised to legalize abortions up to 12 weeks. Tusk—and his ministers of the government—are the reason that this pro-abortion bill, along with three others, were put before parliament.⁴

Nonsensical Call for Coercive Population Control

The CCP Plan to Erase Religion and Religious History

The Chinese Communist Party has started a new campaign to erase religion and religious history. According to the *National Catholic Register*, the campaign involves the widespread renaming of villages across Xinjiang.
