1. Bequest of specific dollar amount

I hereby give, devise and bequeath _____ and No/100 dollars (\$DOLLARS) to the Population Research Institute Inc., a nonprofit organization, EIN# 54-1819935 with an address at P.O. Box 1559, Front Royal, VA 22630, for the Population Research Institute's general use and purpose.

2. Bequest of Specific Personal Property

I hereby give, devise and bequeath [DESCRIPTION OF PROPERTY] to the Population Research Institute Inc., a nonprofit organization, EIN# 54-1819935 with an address at P.O. Box 1559, Front Royal, VA 22630, for the Population Research Institute's general use and purpose.

3. Bequest of Specific Real Estate

7. Restricted Bequests
